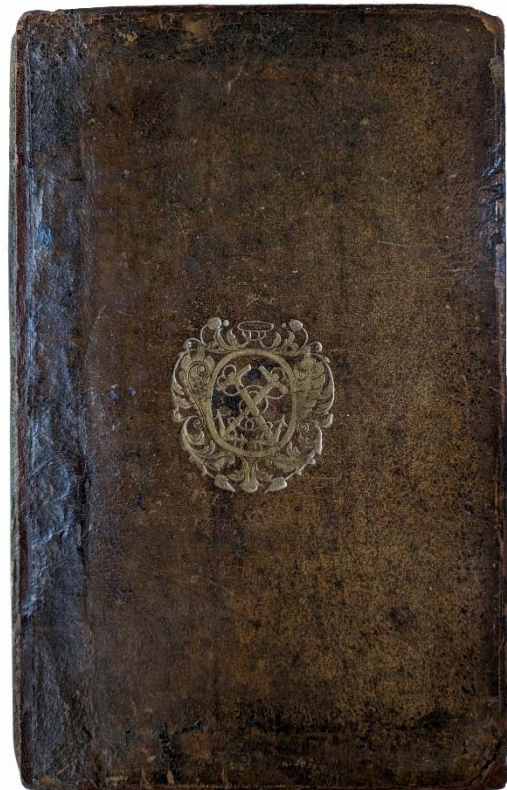
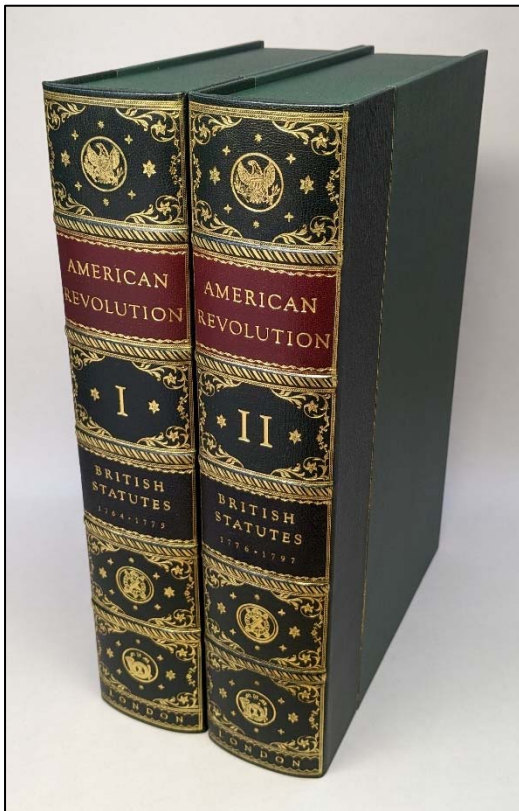

**PROVENANCE:** The ACTS in this collection were extracted from a series of volumes deaccessioned by the British Admiralty Library, but exhibit no markings to confirm the association. The volumes were bound in eighteenth century full calf, with the Admiralty Library armorial crest (consisting of crossed ship anchors within an ornate shield) deeply gilt-impresed into the boards (*see above right*). To maintain a link to this important provenance, two of the armorial-crested boards are included with the collection.

## BRITISH LEGISLATION AND THE AMERICAN WAR OF INDEPENDENCE

The central events leading up to the American Revolution (1775-1783) were provoked almost exclusively by British Parliamentary legislation that was designed to impose and maintain American colonial subservience to Great Britain. The American colonies were managed according to strict mercantilist economic policies, and British attempts to assert ever-greater control over a wide range of colonial affairs caused growing tension between the Thirteen Colonies and the British government. That tension soon erupted into full-scale war, and led to the self-declared independence of the American colonies and creation of the United States of America as a federal republic.

Some years earlier, the French and Indian War (1754-1763) in America had resulted in the conquest of a vast new territory for Great Britain, but at great monetary and human sacrifice. The conflict left Britain deeply in debt and unable and generally unwilling to cover the expenses for administering the new Province of Quebec and military protection of the American colonies from Native attacks along western frontier border regions.

Following the Treaty of Paris (1763) which formally ended the French and Indian War, the newly-installed British Prime Minister, George Grenville, First Lord of the Treasury and Chancellor of the Exchequer, worked to revise and extend the scope of taxation of the American colonies with the aim of raising funds directly from the colonies to pay for the expanded colonial administration and necessary British military protection.

In addition to new tax laws, a flood of other legislation specifically aimed at managing American colonial affairs was planned. Imperial authorities also sought to mandate the billeting of British troops in the colonies. These new initiatives were met with heated protests from colonists who resented the lack of proper representation in British Parliament and demanded the same rights and freedoms as other British subjects.

Grenville's GENERAL REVENUE ACT (*or* SUGAR ACT), 1764 was the first piece of legislation in his plan to revise the taxation structure in the American colonies and set new regulations on trade and commerce. Funds raised by the GENERAL REVENUE ACT, 1764 were earmarked in the SINKING FUND ACTS of 1765, 1766, and 1767 for specific use in "defending, protecting, and securing the British Colonies and Plantations in America."

The STAMP ACT, 1765 was another tax law authorized by Grenville to offset expenses of colonial management and defense. It levied taxes on all legal and commercial papers, pamphlets, newspapers, almanacs, cards, and dice by means of printed or embossed revenue stamps. Outrage against the stamp tax legislation was immediate and universal, and was accompanied by acts of civil disobedience and rioting. American colonists refused to abide by the law, and most of the stamped paper sent to America for the purposes of the ACT was destroyed. In the Province of Quebec, the rules were largely followed, and stamped paper was used in accordance with the ACT. Consequently, rare surviving examples of stamped paper documents are from Quebec, Montreal, and Trois Riviere.

When the STAMP ACT, 1765 was repealed in its entirety by the STAMP ACT (1765) REPEAL, 1766, it was replaced by a new law that initiated a period of heightened authoritative control over the colonies. The DECLARATORY ACT, 1766 stated that all resolutions, votes, orders and proceedings by any of the Houses of Representatives in America were null and void, and that the colonies and plantations in America were subordinate to, and dependent upon, the Imperial Crown and Parliament of Great Britain.

In 1767 and 1768, a series of five laws was passed by the British government to raise revenue from the American colonies to pay the salaries of governors and judges, create a more effective means of enforcing compliance with trade regulations, punish the colony of New York for failing to comply with the QUARTERING ACT, 1765, and to clearly re-establish the precedent that Parliament had the right to tax the colonies. The unpopular laws, which became known as the TOWNSHEND ACTS (after Charles Townshend, Chancellor of the Exchequer of Great Britain and architect of the legislation) consisted of the COMMISSIONERS OF CUSTOMS ACT, 1767; the REVENUE ACT, 1767 (which placed a tax on tea of three pence per pound); the INDEMNITY ACT, 1767; the NEW YORK RESTRAINING ACT, 1767; and the VICE ADMIRALTY COURT ACT, 1768. The TOWNSHEND ACTS were met with huge resistance in the colonies, and prompted the occupation of Boston by British troops in 1768, which eventually led to the Boston Massacre of 1770.

The massacre at Boston motivated Parliament to reconsider the TOWNSHEND ACTS: many of the taxes were repealed, but the tax on tea remained. Colonists were further aggravated when the British government passed the TEA ACT, 1773 to allow the financially-troubled East India Company to ship their excess tea holdings to America at a reduced tax rate, thereby undercutting American importers (and smugglers). The legislation was considered symbolic of British taxation tyranny, and colonial resistance to the policy culminated in the Boston Tea Party of 16 December 1773 wherein more than 92,000 pounds of East India Company tea was dumped into Boston Harbor.

In direct response to the Boston Tea Party, a wave of punitive laws was passed by the administration of Frederick North, 2<sup>nd</sup> Earl of Guilford, British Prime Minister, First Lord of the Treasury, and Chancellor of the Exchequer. Known as the INTOLERABLE ACTS, the laws consisted of the BOSTON PORT ACT, 1774; the ADMINISTRATION OF JUSTICE ACT, 1774; the MASSACHUSETTS GOVERNMENT ACT, 1774; and the QUARTERING ACT, 1774. The ACTS closed the port of Boston, put Massachusetts under military control, and banned public meetings. The QUEBEC ACT, 1774, generally considered to be one of the INTOLERABLE ACTS, greatly enlarged the boundaries of the Province of Quebec and passed reforms favorable to the Catholic French, which further infuriated American colonists.

The INTOLERABLE ACTS were viewed as direct violations against American colonial civil rights, and in September of 1774 the First Continental Congress was organized to coordinate protests. As tensions escalated in February 1775, Massachusetts rose to a state of rebellion. By 19 April 1775, war had broken out between British troops and Patriot militia at Lexington and Concord, Massachusetts. The American Revolution had begun.

On 23 August 1775, King George III issued his “Proclamation for Suppressing Rebellion and Sedition” to declare that the American colonies were in open rebellion to his authority and were subject to penalties as traitorous rebels. In essence, the King’s announcement amounted to a Declaration of War against the Thirteen Colonies. Trade, commerce, and coastal Atlantic fishing rights came under strict British control through the passing of the NEW ENGLAND RESTRAINING ACT, 1775, the SOUTHERN COLONIES RESTRAINING ACT, 1775, and the NEWFOUNDLAND FISHERIES ACT, 1775.

On 4 July 1776, the Second Continental Congress ratified the Declaration of Independence. The Declaration explained that the Thirteen Colonies (consisting of New Hampshire, Massachusetts Bay, Rhode Island, Connecticut, New York, New Jersey, Pennsylvania,

Maryland, Delaware, Virginia, North Carolina, South Carolina, and Georgia) regarded themselves as independent sovereign states that were no longer under British rule.

Britain responded by passing the PROHIBITORY ACT, 1776 which terminated all trade between Great Britain and the American colonies, and removed the King's protection. The law was followed up by a series of ACTS that empowered the British Admiralty to authorize commanders of British vessels to seize ships and related property owned by residents of the rebellious colonies, namely the CAPTURES ACT, 1777; CARRYING CAPTURES INTO PORT ACT, 1777; and CAPTORS OF PRIZES ACT, 1778. The HIGH TREASON IN AMERICA ACT, 1777 maintained that anyone charged or suspected of high treason or piracy in America could be held in custody without bail or trial.

In 1778, the British government relented in a limited way and passed three CONCILIATORY ACTS: the MASSACHUSETTS GOVERNMENT ACT (1774) REPEAL, 1778; the REVENUE ACT (1767) REPEAL, 1778 (which finally removed the tax on tea); and the COMMISSIONERS FOR QUIETING DISORDERS ACT, 1778. Within a few years, the RESTORATION OF CERTAIN TRADE ACT, 1780 allowed for limited trade and commerce to resume.

By 1782, the war was coming to an end. The AMERICAN PRISONERS ACT, 1782 made provisions for prisoner exchange, and the TRUCE WITH AMERICA ACT, 1782 enabled Britain to make preparations for restoring peace, intercourse, trade, and commerce with the Thirteen Colonies.

The following year, progress was made to restore trade and navigation by means of the TRADE AND INTERCOURSE WITH AMERICA ACT, 1783 and the NAVIGATION AND TRADE ACT, 1783. American colonists and officials who had remained loyal to the British crown throughout the war were recognized for their sacrifices and losses through the series of COMPENSATION FOR LOYALISTS ACTS passed between 1783 and 1790.

The American Revolution officially ended with the signing of the Treaty of Paris (1783). The Treaty covered recognition of sovereignty, international boundaries, fishing rights, financial agreements, property rights and occupation, prisoners of war, and prisoner exchange.

Several treaty initiatives remained unresolved until John Jay, the First Chief Justice of the United States, negotiated The Treaty of Amity, Commerce, and Navigation between His Britannic Majesty and the United States of America (better known as Jay's Treaty) in 1795. The final document in the collection, titled JAY'S TREATY RATIFICATION ACT, 1797 confirmed Great Britain's acceptance of the agreement and expanded on some of the issues that were finally sorted out between the two countries.

Aside from the salient British ACTS that precipitated rebellion in the American colonies, the collection also contains many "non-confrontational" ACTS that were issued for a variety of economic and domestic concerns of importance to the colonies, such as COLONIAL CURRENCY, NATURALIZATION, SEAMEN IN THE MERCHANTS SERVICE, and POSTAL SERVICES. Some of the laws were made valid for only a limited time, but many were renewed yearly or periodically on an as-needed basis, such as legislation on MUTINY AND DESERTION, the SINKING FUND, HIGH TREASON, and NAVIGATION AND TRADE, as well as regulations governing staple commodities that were so vital to the American economy, including MOLASSES, SUGAR, RICE, SILK, INDIGO, and TOBACCO.
